Stage 2

Beginning May 6, 2020

Park Office will have limited hours – We will be open Wednesday and Friday from 10:00AM - 2:00PM or by appointment

Public meetings will be conducted virtually via Zoom Meeting. For virtual access to meetings, please contact Park Program Director at 574-773-2112 x 2108.

Beginning May 11, 2020

McCormick Creek Golf Course will continue to operate following CDC guidelines. Full seasonal green fees and golf cart rates will be in effect. Payments will be made upon arrival. Tee times are still required.

Adams Golf Shop will be open with limited access to the pro shop for merchandise purchases and golf fee payments. Capacity of the shop will be set at 10 or under due to the space in the shop.

Stage 3

Beginning approximately May 26, 2020, or later if directed by Governor

Park Office will have daily hours – We will be open Monday through Friday from 10:00AM - 2:00PM

Playgrounds, tennis courts, basketball court, skate park, sand volleyball court, and the dog park will open with social/physical distancing guidelines in place.

Restrooms on Oakland Ave. and at Little League Field 1 will be open for public use during limited hours. Disinfection processes will be put in place but use of these amenities should be limited and used with caution.

Wado-Kai Karate Class can resume with proper social/physical distancing and no contact.

McCormick Creek Golf Course will continue to operate following CDC guidelines. Golf outings will be permitted with 18 teams or less and no social gathering and/or served meal on location. Trash cans and ball washers will be on the course. Divot sand will be on the golf carts. Tee times are still required.

Public meetings will be conducted in-person and virtually via Zoom Meeting. For access to meetings, please contact Park Program Director at 574-773-2112 x 2108. We will have limited capacity to maintain proper social distancing.

Stage 4

Beginning June 15, 2020, or later if directed by Governor

*Nappanee Pool may open with very strict Health Department Guidelines

McCormick Creek Golf Course may resume hosting full golf outings with no social gathering and/or served meal on location.

Recreational sports leagues may resume practices, games and tournaments.

Facility use/rentals may resume (i.e. West Park Pavilion, open air pavilions, and sports fields). Renters must adhere to social gathering guidelines.

Stage 5

Beginning July 6, 2020, or later if directed by Governor

Remaining operations of Nappanee Parks will return to pre-COVID-19 conditions, but with social/physical distancing and CDC guidelines. Programs, swim lessons**, events, etc. will be evaluated and rescheduled if feasible.
